

History of Psychoanalysis

This collection was created in the Spring of 2019 to provide access to works that, while not necessarily BPSI-related, are part of the history of psychoanalysis (currently the collection spans from 1929-1989). Included in the collection is an analysis of the personality of Adolf Hitler, An outline of neuropsychiatric procedures in the U.S. Navy, and a grant proposal for autism research from 1978. The collection has one subseries for materials produced by the Group for the Advancement of Psychoanalysis (GAP). The folders are arranged chronologically besides the GAP subseries, which is consolidated in Box 2.
