Psyche and the Social Surround

The main objective of this course is as a primer and introduction to the topic of the intrapsychic and the social surround. A secondary objective is to review the controversy between the intrapsychic and the social surround in psychoanalysis and view the many ways that U.S. psychoanalysis is addressing the limitations of this divide. The content will show that U.S. psychoanalysts are generating another iteration of psychoanalysis that holds near the old established theories, critically evaluates their application in the present, and invites continued newness in practice, which has always been the case for psychoanalysis. The strict divide between attention to the intrapsychic and the social surround has been prominent in U.S. psychoanalysis. Exclusive attention to the intrapsychic has, for many decades, been privileged as the truest form of psychoanalytic practice. The origin of this divide is multi-pronged and likely overdetermined and will be discussed throughout this course. To situate the class in the present, the first meeting will address the current social surround in the United States and discuss how it is shaping new knowledge about the intrapsychic. The issue of race, anti-racist agendas, and the covid pandemic as a catalyst and push factor for change will be reviewed. The next two classes will visit some of the issues that led to the intrapsychic and social surround divide such as the evolution of Freud's early theoretical proposals, the immigration of European psychoanalysts to the United States during World War II, and the specific way health systems developed and created disparities and issues of access for some groups that were already facing marginalization. A set of subsequent classes will discuss the influence of the social surround on the psychoanalysts' subjectivity, and how that, in turn, coalesces with practice and the continued development of psychoanalysis. The remaining classes will provide examples of ways in which psychoanalysis is moving beyond this divide in its work with marginalized populations, individuals impacted by trauma, and psychoanalytic approaches to work with large group traumas. The concept of psychoanalysis as a liberatory practice (adapted from the Martin-Baró's liberation psychology) and many other novel and exciting theoretical formulations will be discussed in the course's assigned content. Wherever possible, the instructor included a podcast that features the author of the paper assigned for that week with the hope to further enliven the material.
