## CLINICAL PSYCHOANALYTIC WORK: TOWARDS GRASPING THE "HOW" OF IT

OVERVIEW: Using close study of the clinical work of group members, this class will try to 'deconstruct' the variety of what we do and how we do it ("technique"?) with an eye to illumination and personal awareness. The assigned reading forms a backdrop to each meeting, a point of shared reference and resonance, meant to be supplemental to the clinical explorations. We are asking, in addition, for a small piece of writing before class, perhaps a paragraph, to facilitate reflections.

I "Psychoanalytic Technique": What Is It? What is it not? Misnomer? Learning Objective: Identify two ways of describing "the how" of work in psychoanalytic practice.

**Small Written Piece**: "What I think of, when I think of "technique"—what is it to me so far..."
